Justice Philip Jeyaretnam
President, Singapore International Commercial Court

Justice Philip Jeyaretnam is the President of the Singapore International Commercial Court. His focus since joining the Bench in 2021 has been on complex commercial cases, arbitration law, building and construction, company and trust law. He is also a member of the Judicial Service Commission, and the Presidential Council for Minority Rights. While in practice, he was recognised as an expert in commercial litigation, arbitration and construction law in all major legal publications. In 2020, the Law Society

conferred on him the CC Tan Award. He was managing partner of Rodyk & Davidson LLP from 2011, and, following its combination with Dentons, ASEAN CEO. Justice Jeyaretnam was the founding chairperson of the Society of Construction Law (Singapore), from 2002 to 2004, and served as the President of the Law Society during the years 2004 to 2007.
